

## FindCoco.Com Terms of Service and Use

### **Acceptance of the Terms of Service and Use**

These Terms of Service and Use are entered into by and between You and FindCoco.com ("Company", "we" or "us"). You agree that the address you provide will be shared on the Website map when you register (however no

Alerts must only contain information relevant to the missing pet and must comply with the Content Standards set out in these Terms of Service and Use. When you declare an alert you may also offer a reward, which will be mentioned on the alert. FindCoco.com does not collect, or in any way get involved with distributing the reward to the other party and is not in any way responsible for the reward. You must cancel the alert when your pet has been found. FindCoco.com does not guarantee that you will be able to locate your missing pet if you have declared an alert.

Receiving an Alert: FindCoco.com will not charge you to receive alerts from other members. Message and data rates from your wireless provider may apply.

Information Received from User Contributions: You agree to not use any information received from or through FindCoco.com, including alerts and messages, for any other purpose other than to help look for a missing pet, if you choose to do so.
